# What's New?

## ESEA Waiver

- Accountability Designations
  - Districts in Good Standing (formerly Group II)
    - Reward: Highest Achieving
    - Good Standing/Acceptable
  - Focus Districts (formerly Group I, Big 5, etc.)
    - 121 LEAs
      - » Focus Schools: accountability
      - » Priority Schools: lowest performing in State



# What's New?

## Consolidated Application

- **New Format**
  - “Base” Application: **ALL LEAs** must complete
    - *Minimal requirements (“shorter”)*
      - Good Standing *and* Focus LEAs; including Focus Charter Schools
  - Accountability Addendum:
    - Focus LEAs *and*
    - Focus Charter Schools



# What's New?

## “Base” Application

- *All LEAs*
  - Transferability
    - Up to **100%** use of the funds (Title IIA, REAP)
    - **ONLY INTO** Title I; never OUT of Title I
    - To report transferability of funds, check box within Budget Narrative Form. The on-line form has been eliminated.



## What's New?

# “Base” Application

- *ALL* LEAs continued
  - Parent Involvement Plan (PIP)
    - *Not* collected in application
    - Collected during *ALL* monitoring formats for compliance and implementation
  - Highly Qualified Teachers (HQT)
    - 5 % reserve **Deleted**



## What's New? “Base” Application

- *ALL* LEAs continued
  - Teacher Quality Plan (TQP)
    - **Waived**
  - SES and Choice
    - 20% reserve **Waived**
  - Rural Education Assistance Program (REAP)
    - accountability requirement (funds used for improvement if LEA identified) **Waived.**



## What's New?

### “Base” Application (Continued)

- *ALL LEAs* continued
  - Required Set- Asides
    - Homeless
      - non-Title I buildings
      - “portion” of their Title I A funds to provide services to students who are homeless
    - Parent Involvement
      - For Title I A allocations greater than \$500,000, 1% is required

# Accountability Addendum

- Accountability Addendum: **Focus Districts**  
**ONLY**
  - Requirements: in addition to “Base” Application
    - District Comprehensive Improvement Plan (DCIP)
      - Develop & Implement SY 2012-13
    - Comprehensive Education Plan (CEP)
      - Develop & Implement SY 2012-13
    - School Choice
      - Required
    - Supplemental Education Services (SES)
      - Optional

## Accountability Addendum

- Accountability Addendum: **Focus Districts ONLY**
  - Set-Asides for Improvement
    - NYSED sets LEA % rate
      - Applied to Titles IA, IIA & IIIA if LEP identified
  - Limited List of Allowable Activities
    - DCIP

      - Section 2.E iii (page 109-112) explains & lists activities.

# USDE Findings: Private Schools

- USDE Requirements
  - Private School Participation Form
    - Revised from previous years
  - **Evaluation** of Program
    - LEA is required to assess/consult with the private schools regarding the Title I academic program



# USDE Findings: Private Schools

- USDE Requirements: continued
  - **Inventory Control: materials, property, equipment**
    - LEA: must maintain control of Title I purchased inventory
      - » order, procure, tag, dispose
    - If private school closes:
      - » Inventory is returned to LEA
      - » LEA reassigns to another private school or LEA Title I program(s)



# USDE Findings: Private Schools

- USDE Requirements: continued
  - **Third Party Contract Requirements**
    - Administrative Costs, Parent Involvement (PI) & Professional Development (PD) are separate: “ON TOP” of Instructional Amounts
    - Must be broken out on Invoices and records
    - Contractors *CANNOT* submit for administrative fees or other non-instructional charges that ARE NOT in contract
    - Instructional Services allocations *CANNOT* be USED for Administrative, PD or PI requirements



# USDE Findings: Private Schools

- USDE Requirements: continued
  - Private Schools **are** Targeted Assistance Schools
    - Only Title I Students, their Families & Instructional Staff may participate
    - Title I funds must be used for Federal Programs **only**
    - Title I funds **cannot** be used for general needs of private schools
    - Supplies without program services **are not** allowed.



# USDE Findings: Private Schools

- Title II, Part A
  - Advisory Amounts
    - Recalculate the allocation for the provision of equitable services to non-public/private schools under Title II, Part A, for fiscal years 2007-08 through FY 2011-12
    - To provide equitable professional development services for Non-public/Private Schools.

- Title II, Part A: continued
  - Field Memo: ESEA Title II, Part A – Adjustments to Equitable Participation for Non- Public/Private Schools
  - Sent June 21, 2012

## Fiscal

- Set-Asides: Parent Involvement
  - Districts in Good Standing
    - Title I A allocations greater than \$500,000, 1% is required
  - Focus Districts
    - Title I A allocations greater than \$500,000, 1% is required **and an additional 1%** for Family Engagement activities for designated Focus and Priority Schools within the Focus District's LEA.



# Forms

- Forms to be completed by *ALL* LEAs:
  - Title I Application Supplement (due 8-31-12)
    - Supplement Changes: T.B.D.
  - Title I Comparability Report Form (due 11-30-12)
  - The Administrative Position Description Form(s) if applicable. A hard copy of this form should be included with the FS-10 of the program that is funding the position.
  - Title I Schoolwide Program Notification Form (if applicable)



# Submission Instructions

- Consolidated Application: *ALL* LEAs
  - One Complete Original Application (blue ink signature) Hard Copy including Assurances & Certifications
    - Hard Copies of all appropriate signature pages:
      - » Consultation/Collaboration Form
      - » Private School Participation Form
      - » Part D Neglected & Delinquent Form
  - Two CDs (word format) labeled with LEA name/contact information



# Submission Instructions

- Budgets: *ALL* LEAs
  - Budgets (FS-10)
    - 1 Original with Signature (blue ink) and **3** copies
      - Each Title applied for: Titles I A&D, IIA, IIIA & VI B (REAP)
    - All budgets must also contain
      - Agency Code (LEA's BEDS Code)
      - Project Number (LEA's unique sequence: 1<sup>st</sup> 4 digits given)
        - » Title I A&D      0021
        - » Title II A        0147
        - » Title III A        0149
        - » Title VI B         0006



# Submission Instructions

- Compile and Submit: *ALL* LEAs
  - Consolidated Application: One complete original hard-copy and 2 CDs (labeled)
  - Budgets (FS-10s): band together each title (original, 3 copies) and narrative
    - In Title order, begin w/Title I, Title II, etc; following the Consolidated Application
