New York City Preschool Interim Alternative Bilingual Placement (IABP) Training Program February 2020

Introduction/Background	Efforts to increase the number of 4410 bilingual preschool programs in New York City (NYC) continue to be impacted by a shortage of bilingual special education teachers available for employment. The New York State Education Department (NYSED) is seeking information to inform the development of a staff training program that helps address the needs of preschool students with disabilities who are culturally and linguistically diverse (CLD).
Purpose/Goal	This training program would provide professional development for approved 4410 preschool programs in NYC. Completion of this program and other requirements would allow approved preschools to offer interim alternative bilingual placements (IABPs) to preschool students with disabilities when no bilingual program is available.
Responders Include	Responders to this RFI should include, but are not limited to 4410 preschools, local education agencies (LEAs), other interested state or federal entities, not-for-profit or for-profit organizations, creators, publishers or vendors of educational training programs, professional organizations, institutions of higher education (IHEs), and educational researchers or other experts in professional development and/or the needs of preschool students with disabilities who are culturally and linguistically diverse (CLD).

PURPOSE OF THIS REQUEST FOR INFORMATION

The New York State Education Department (NYSED) is seeking information about the development of a training program to provide professional development for certain staff in approved 4410 preschool programs in NYC that is focused on the unique needs of preschool students with disabilities who are culturally and linguistically diverse (CLD).

There continues to be a need for additional approved bilingual preschool programs in some areas of NYC due to a shortage of bilingual special education teachers and related service providers with the bilingual extension to their certification. When adequate personnel with bilingual certification are not available, approved preschool programs may offer interim alternative bilingual placements (IABPs) to preschool students with disabilities if certain conditions are met. One such condition is that personnel receive training on the unique needs of preschool students with disabilities who are bilingual.

This Request for Information (RFI) is being conducted to solicit information about the need for training for IABPs in NYC, the best way to deliver this training and what specific content should be included.

All parties with knowledge, skills and expertise in this area are encouraged to respond. Responders should include, but are not limited to 4410 preschools, local education agencies (LEAs), not-for-profit or for-profit organizations, creators, publishers or vendors of educational training programs, professional organizations, institutions of higher education (IHEs), and educational researchers or other experts in professional development and/or the needs of preschool students with disabilities who are culturally and linguistically diverse (CLD). NYSED may use the information received, as well as existing documentation, to prepare a Request for Proposal (RFP). All parties with expertise on professional development and/or the needs of preschool students with disabilities are encouraged to respond to this RFI. Doing so, or not doing so, will not disqualify a party from submitting a bid for a subsequent RFP should one be issued by the NYS Education Department.

BACKGROUND INFORMATION

Over the past two decades, preschool programs for students with disabilities approved by NYSED have made progress in increasing the availability of bilingual programs and in enhancing the bilingual training and resources available to ensure that preschoolers who are CLD have access to the widest possible array of programs and services in the least restrictive environment. However, assessment of NYC regional need shows a continued need for additional bilingual preschool programs across the continuum and in many areas of the city.

For many years NYSED has funded programs designed to increase the number of bilingually certified professionals in certain special education titles—including preschool teachers and related service providers with bilingual extensions to their certification. Despite these efforts, the shortage of preschool special education teachers and related service providers with bilingual extensions persists in NYC. To help ensure that preschool students with disabilities who are CLD can be served, NYSED allows approved preschool programs to enroll preschoolers who are CLD in IABPs when no approved bilingual program is available if the preschool program has an approved IABP plan.

New and continued approval of an IABP plan requires that programs that do not have a special education teacher who holds a bilingual extension must have:

- a bilingual paraprofessional assigned to the classroom, and
- the linguistic capability of providing instruction and using methodology tailored to the cultural and linguistic needs of preschoolers who are CLD through the use of a special education teacher who
 - o has completed the training described below, or
 - o is also certified in English to speakers of other languages (ESOL), or
 - o is enrolled in a program leading to a bilingual extension or ESOL certification.

An additional requirement of this IABP plan is training for paraprofessionals, teachers, preschool administrators and interpreters/translators on the unique need of preschoolers with disabilities who are CLD.

Currently, this training for approved preschool programs to administer IAPBs is delivered through the NYC Preschool Bilingual/English as a New Language (ENL) Professional Development Center (PDC) at Long Island University-Brooklyn (LIU-Brooklyn). The NYC Preschool Bilingual/ENL PDC provides training courses for administrators, teachers, paraprofessionals, interpreter/translators, related service providers and evaluators in approved preschool programs. Training content includes:

- bilingual and ESL methodology;
- cultural and linguistic diversity;
- effective professional/paraprofessional teams;
- working as or with an interpreter; and,
- integration of bilingual programming throughout a school.

The NYC Preschool Bilingual/ENL PDC provides a series of in-person trainings for all participants, as well as an online training for administrators. Table 1 provides an overview of courses for various participants as required in the current contract.

- 4. How much training is necessary to ensure that 4410 preschool staff have an adequate level of understanding to provide IABPs?
- 5. What essential content should be covered in the training? Please discuss the rationale behind your response.
- 6. What is the best way to deliver training to reach the largest number of participants in the timeliest manner (e.g. in-person training series, webinar, asynchronous online courses, combination of in-person and online)? Please discuss the rationale behind your response, including the proposed benefits and drawbacks of training methods.
