Refer to the <i>SIRS Manual</i> for assignment/course codes.

May 26, 2017	Course Instructor Assignment and Student Class Entry Exit Data Due	Required for the reporting of course and staff data for State and federal purposes. These data will not be certified in 2016-2017, but must be complete for a comparison with ePMF data which will be eliminated in 2017-2018.
June 16, 2017	2016–2017 Staff Student Course (TSDL records) (SIRS 315) Data Due  Staff Assignment (SIRS 318) (Principals only) Data Due	Submit final TSDL (Staff Student Course) and Staff Assignment data, including linkage and duration, for all teachers and principals to be used for 2016-2017 teacher and principal State-provided growth score calculation purposes. Staff Student Course records should be verified using the Level 2 SIRS-315 Teacher Student Data Linkage (TSDL) Verification Report.  Used for 2016–2017 Principal State-provided growth score calculation purposes.
June 23, 2017	2016–2017 Staff Student Course (TSDL) (SIRS 315) and Staff Assignment (SIRS 318) (Principals only) Data Statement of Certification	Certify the accuracy of the data submitted as of the reporting deadline (Certification of Principals only in Staff Assignment.) in the NYSED Business Portal. Staff Assignment records should be verified using the Level 2 SIRS-318 Staff Assignment Verification Report.
June 27, 2017	<b>ePMF Teaching Data</b>  Out of Certification Reports Generated  <b>TAA is Unlocked</b> The ePMF Forms are unlocked for administrator review/corrections	Processing will be based on ePMF <u>teacher</u> submitted forms. Reports will be posted to the NYSED Business Portal for school district, BOCES, and charter school review.  CEOs must un-submit ePMF forms and then recertify in TAA, if corrections were made as a result of the Out of Certification report.
July 28, 2017	ePMF Application Closes	ePMF forms must be corrected and certified by the CEO in TAA.
August 2017	Final Out of Certification Reports Generated	Reports will be posted to the NYSED Business Portal for school district, BOCES, and charter school review.
August 25 to October 27, 2017	Start of collection for 2016-17 Evaluation Composite, Category Ratings, and Subcomponent Scores and Ratings Data Extract	2016-17 Staff Evaluation scores and ratings to fulfill data reporting requirements under Education Law 3012-d. <u>Eligibility for 2017-2018 State Aid is dependent upon submission of Staff Evaluation data for school districts only.</u>

August 25, 2017	2016-2017 Staff Tenure (SIRS 322) Data Due	For a complete list of Tenure Codes (see <i>SIRS Manual</i> ). As part of End of Year SIRS Collection.

September 8, 2017	2016-2017 Staff Tenure (SIRS 322) Certification	Certify the accuracy of the data submitted as of the end of year reporting deadline in the NYSED Business Portal.* This will be certified on the SIRS End of Year (EOY) Certification form.
