**General Information**

- This form should be used to report test results for students with limited English proficiency who took the Native Language Writing Test or the alternative language editions of the Regents competency tests in August 2007, January 2008, or June 2008.
- The Native Language Writing Test is designed to allow students to demonstrate their ability to read and write in their native language. To meet the competency requirements in reading and writing, these students must also demonstrate proficiency in English on an acceptable English as a second language (ESL) test. - Report combined results for general-education students and students with disabilities by gender.
