Description Regents Item:	Mott Hall Charter School is requesting to change CSD of location from CSD 9 to CSD 7. MHCS is in its fourth year in a co-located NYC Department of Education site. This site was meant to be temporary and there is not adequate space to run a full program. The school plans to relocate to a private space beginning July 1, 2016.

The application for this school is being reviewed for possible action at an upcoming Board of Regents meeting.

Please note that pursuant to Education Law section 2857(1) and 8 NYCRR 119.4 (available at <http://www.p12.nysed.gov/p12/law.html>), the school district of location is required to hold a public hearing to solicit comments from the community in connection with the foregoing revision. This hearing, which is required to be held within the community that is potentially impacted by the charter school, must be held within 30 days of your receipt of this letter.

- Written confirmation that this hearing was held must be sent to the Charter School Office no later than the next business day following the hearing.
