The Expected Grades with Enrollment form collects information about the grade levels a school will be reporting enrollment for on BEDS day for the 2020-21 school year. The purpose of the collection is to improve state-wide data quality for both state and federal reporting.

All public school districts (outside of New York city) and all charter schools are required to submit the **Expected Grades with Enrollment Form** online using the **IRS Data Exchange** application, available via the NYSED Business Portal at <u>http://portal.nysed.gov</u>.

Only the Superintendent of a School District or a Charter School CEO will be able to access and submit the Expected Grades with Enrollment form.

The Expected Grades with Enrollment online form will be available on **August 1, 2020** in the IRS Data Exchange. The online form should be completed and submitted to SED by **Friday, August 28, 2020**.

Instructions:

Public School Districts: For each school in your district, report the grade(s) you expect to enroll students in for the school year 2020-21. All the schools in a district will be displayed on a single form. Each school will be displayed as single row with a "Grades Expected' column containing checkboxes for each grade, along with the School Name, BEDSCODE and Institution ID. For each school on the collection form, check the box next to the grade level(s) you expect to enroll students in for the school year 2020-21.

- You must report at least one grade level for each school.
- Schools that enroll students in half-day or full-day Kindergarten should check the box for 'K'.

Charter Schools: Report the grade(s) you expect to enroll students in for the school year 2020-21. Your school will be displayed as single row with a "Grades Expected' column containing checkboxes for each grade, along with the School Name, BEDSCODE and Institution ID. Check the box next to the grade level(s) you expect to enroll students in for the school year 2020-21.

- If your Charter School has multiple sites, report the expected grades with enrollment for <u>all</u> sites under the Charter School's main BEDS code.
