SIRS 303-Annual Secondary Assessment Summary

About the Report

The SIRS-303 report displays, by school year, the counts of secondary assessments reported by the LEA that are not included in any other verification report. This report is available to public school districts, charter schools and participating religious/independent schools that reported any of the following Test Groups: *ADV, ALTREG, CCR, LOTE, SEQ, and CDOS.

*Note: Beginning with the 2023-24 school year the Test Group ADV will replace the ALTREG and CCR Test Groups.

Students are included on the Annual Secondary Assessment Summary report if they were enrolled in the reporting entity during the selected school year and one of the types of assessments listed above were reported.

Filtering

At a minimum, a user must select a School Year and District to generate the report. Entities displayed in the dropdowns are determined by a user's entitlements in SEDDAS.

The **District** filter displays the LEA where the student's last regular enrollment was in the selected school year. If there are no students in the district participating in any of the Secondary Assessments (listed above) for the selected school year, the district will not display in the dropdown.

The **Location** filter displays all locations that participated in any of the Secondary Assessments (listed above) within the selected district for the school year chosen. There is also an option to generate a District Rollup. The District Rollup will not include Location Name or Location BEDS Code.

The **Test Group** filter allows the user to view the report for All Students for a selected test group. There is also an option to generate a Test Group Rollup. The Test Group Rollup will not include Test Group or Assessment Name.

The **Assessment** filter allows the user to view the report for All Students for a selected assessment. There is also an option to generate an Assessment Rollup. The Assessment Rollup will not include Assessment Name.

Summary Report

Location Name: The Location Name is the name of the school with reporting responsibility for the student(s).

Location BEDS Code: The Location BEDS Code corresponds to the school with reporting responsibility for the student(s).

Test Group: The short description of the test type being reported.

Assessment Name: The full name of the assessment being reported.

Number Tested: The aggregate count of assessments being reported.

Student Detail Report

The student detail report provides a list of students included in the aggregate count on the summary report. Student name and IDs are provided as well as demographic, program, enrollment, and assessment data that are relevant to the data set. Further information about the terms and service codes used may be found in the [SIRS Manual](#).

Student ID, NYSSIS ID, Student Name, Gender, Ethnicity: Reported as of June 30 of the reporting year or the date of last enrollment record, if prior to June 30.

Location BEDS Code: The Location BEDS Code corresponds to the school where the assessment was reported.

Location Name: The Location Name is the name of the school where the assessment was reported.

Grade: Student's most recent enrollment grade level.

Ethnicity: Students reported with Yes for Hispanic/Latino ethnicity indicator are shown as Hispanic. Students reported with No for Hispanic/Latino ethnicity indicator are shown as the ethnicity indicated by the Race Code reported. If multiple Race Codes are reported for a non-Hispanic/Latino student, the student is shown as Multiracial.

For the following columns, an indicator of YES will appear if a student is reported for at least one day during the selected school year with applicable program service code.

ELL Eligible: This field will display 'YES' for students reported with a Program Service Code 0231.

Former ELL: Students who are not identified as ELL in the current school year but who were identified in at least one of the previous four school years are considered Former ELL. Former ELL status is determined by the Department using a combination of program service and other records reported in SIRS.

Economically Disadvantaged: This field will display 'YES' for students reported with a Program Service Code 0198.

Disability: This field will display 'YES' for students reported with a Program Service Code equal to 5786, 0352, 0363, 0385, 0396, 0407, 0418, 0429, 0440, 0451, 0462, 0473, 0484, or 0495.

Migrant: This field will display 'YES' for students reported with a migrant indicator in the Student Lite template and Programs Fact Record Title I – Part C: Education of Migratory Children — 0330, if applicable (if receiving these services).

Homeless: This field will display 'YES' for a student reported with both a Program Service Code 8262 and a Primary Nighttime Residence Code of D, H, S, T or U.

Parent In Armed Forces: This field will display 'YES' for students reported with a Program Service Code 8292.

In Foster Care: This field will display 'YES' for students reported with a Program Service Code 8300.

Test Information

Assessment Name: The full name of the assessment being reported.

Test Group: The short description of the test type being reported.

Score: The score reported for the assessment. Depending on the assessment, the score may be numeric or alpha.

Standard Achieved: The performance level of the assessment based on the score value.
