During the 2016-17 school year the Manhasset School District invested over \$125,000 in its schools security system by upgrading older model closed circuit cameras to new high resolution cameras. Additional cameras have also been added to increase coverage throughout the school district. Both the increased resolution of each camera and the additional cameras added (now totaling 245) have reduced the time period for which archived footage can be kept on current servers. We have also reached the maximum capacity of the existing servers for number of cameras.

After careful consideration of the increased storage needs, possible future growth of cameras, and the age of existing CCTV servers holding the archived footage, the District has decided to allocate additional Smart Schools Bond Act funds to replace nine existing servers as well as to add six additional servers. This expenditure falls within category three of allowable Smart Schools Bond expenditures – “High Tech Security Features”.
