We had met this requirement in our first proposal and we have since provided even more bandwidth for our students and staff. We now have 2 Gig of bandwidth available which far exceeds the minimum requirement.

Comsewogue School District began deploying WiFi in 2013, and we have continued to maintain and upgrade our Network since. We now have 260+ wireless access points in our district that provides WiFi to all staff and students. Additionally, we have upgraded our overall bandwidth to 2000MBps (2 GIG) to support this. In the coming years, 2023-2024 we are looking to upgrade to WiFi 6, which will be including in our next Technology Plan.

Due to COVID-19 Outbreak, and allocations of government funding differently than anticipated, we will be adjusting the allocation of some monies for Classroom Instruction. We will be investing in our new STEAM Lab and two other design spaces at the High School. These spaces will allow our students to design, create and innovate on a number of projects in the school. Additionally, we are investing in additional STEAM related activities for the elementary schools and Middle School. Additionally, we plan to upgrade our classrooms at the Middle School with newer interactive whiteboard displays. There are some adjustments to the pricing from items for Amendment #1.

Our 1:1 Chromebooks, STEAM Devices, and Interactive Displays, help provide learning opportunities for all of our students. Teachers will have the tools to be able to enhance differentiated instruction through these technologies. By leveraging the technology, teachers can foster multiple learning styles and increase engagement. Learning can now happen inside and outside of the classroom. Additionally, assistive technologies and translation softwares allow our students with disabilities and our ELL students to have assistance in their curriculum.

By having devices in the Classroom and upgrading our devices, we can increase and change the way the students, teachers and parents interact in the classroom. With the technology and infrastructure in place, we can have a Learning Management System be the hub for learning inside and outside the classroom. Due to these systems, teachers can more easily contact their students' parents.

We have a District Administrator for Instructional Technology, a teacher on specialist assignment/Educational Technology Specialist, and our Library Media Specialists in each building available to regularly provide professional development to our teachers, staff and administrators. This regularly scheduled training helps reinforce the new technologies and gives staff the ability to reflect, collaborate and enhance their use of the technology. Additionally, our EdTech Specialist push-in to classrooms to help assist with the use of technology. When appropriate, we also conduct training for our parents in our school district. Lastly, we have a computer technician in each building to be able to provide technical support when needed.
