The Badge Access System is currently obsolete, cannot be expanded, and not integrated with any other systems. We will use the funding to upgrade our Card Access system to a modern implementation that is integrated with our Camera System. We will be re-using physical door swipes and all cabling, so there will be no construction needed for this project.
