The Germantown Central School District currently has 541 students which would require 48.7Mbps to comply with the requirement of Smart Schools Bond Act

The District implemented building-wide wireless internet access during the 2014-2015 school year. The District has increased its broadband to 1000 Mbps prior to 1/1/2018.

The District has moved from 2 classrooms per access point to a new ratio of 1 classroom per access point over the 2017-2018 school year to strengthen our WiFi network and meet user demand.

The District's original Smart School Bond plan was built around purchasing teacher laptops and Chromebooks to support the 1 to 1 initiative. During the waiting period of the District application to be approved the District needed to make the purchases of the laptops and Chromebooks. So the District used general funds to support the purchase of new teachers laptops and additional student Chromebooks due to the need in the District. Since the purchase was made prior to the grant approval the District adjusted the usage of the funds to support the implementation of interactive panels in the classrooms.

The District is now planning to install View Sonic Interactive panels into every classroom throughout the building. The District will be purchasing 55, 75 inch panels and 8, 65 inch panels. Of the 63 total panels 30 of them will be mounted on portable carts (3 of the carts will be purchased with District funding and not through Smart School Bond), 33 will be mounted directly to the walls in the classrooms.

In Germantown Central School District, we have shifted to an Integrated Co-Teaching Model, reducing our self-contained classes. We are also focusing on eliminating barriers to learning, following a Universal Design for Learning template. As a part of this move, we have an increased need for multiple learning stations, as well as multiple means of representation. The interactive boards will allow for students in larger classes to be split into smaller groups to receive the same instruction, as well as to aid in remedial and accelerated learning within the general education space.

Regarding our district instructional technology plan, all of our classrooms need to be prepared not only for remote learning but also for the potential needs of assistive technology in an in-person model. The interactive boards would allow all faculty the ability to quickly pivot to a remote model. For our in-person instruction, students with disabilities, as well as our ENL population, who need varied representations of content and multiple means of knowledge demonstration, the interactive boards will allow for further varied means. To address the learning gaps in various cohorts, our faculty has employed the use of multiple curricula; the interactive boards will allow both students and faculty to access this curriculum in varied grouping sizes, and within all learning spaces.

Parents and students have access to teacher's gradebooks and actively track their achievement. Zoom is used as an option for homebound, tutoring, and virtual through distant learning opportunities from regional partners. Communications with school staff will be enhanced through Google Docs. Students can use their devices to add to their student portfolio through Naviance and showcase their work throughout school and even into higher education. The ease of making these products available to stakeholders can potentially improve community perception of the District
