Bemus Point has used several funding sources to provide a robust network to support student educational goals. Unfortunately, a critical component in the system is vulnerable. The network depends on Intermediate Network Distribution Closets. These "closets" are the critical data distribution locations in the buildings. All network devices, including Voip Phones, computers, access points, and emergency notification, depend on the data switching units located in these closets. Unfortunately, these closets were often installed in a convenient location with no consideration for power supply, room security, or Hvac. The most expensive and delicate switching devices in the system are often in janitorial closets with running water, library storage rooms, or even a teachers lounge.

Bemus Point Central Schools has identified these as a priority for improving the reliability of their network. These renovated closets will be connected to electrical circuits that are attached to the building emergency generator to insure the availability of emergency communication during a loss of power. They will also have door locks with swipe cards installed to manage the people who should and who shouldn't have access to these devices. Finally, they will have dedicated environmental controls and systems installed. These units will control the heat and air conditioning for these delicate devices. This will improve reliability and extend the life of the switching units.

Bemus Point has established a one-to-one learning environment to help students achieve and reach their individual potential and goals. The data network is one critical element in that environment. Without a reliable, robust network transmission all the devices in the building are relegated to paper weight status and students are returned to a traditional lecture style classroom. This proposal seeks to protect the critical components in the network and insure availability of the network.

An informal team of administrators, technicians and district architects consult regularly to review the academic goals for specific educational spaces, the number of students that might be located there, and the availability of network services. This team makes recommendations for the upgrade of services as required by the educational goals of the space.
