The District has moved from 2 classrooms per access point to a new ratio of 1 classroom per access point over the 2017-2018 school year to strengthen our WiFi network and meet user demand.

Students are allowed to take their devices home with them to extend learning outside of the classroom and provide access to their work and virtual opportunities. This is to bridge learning gaps caused by the pandemic. Students are more likely to engage with interactive educational content in and outside of school. English Language Learners will be able to benefit from a wealth of software in and outside of the school building. Students with reading gaps can access specialized reading remediation software resources. Assessments and lessons are computer adapted and use psychometrics to adjust to each student's instructional level. Zoom will be used for hombound and virtual students to ensure continued access and support to academic growth. Students with Disabilities (SWD's) use technology to make instruction and learning more accessible to them. SWD's use a variety of devices such as IPads, Chromebooks, specialized peripherals and specialized software. Some of the benefits for SWD's are:

- Students use their device to engage in online courseware in an environment less distracting than a traditional classroom
- Textbooks are online, reducing the need to carry or store heavy textbooks in home and at school
- SWD's devices include assistive technology such as scanning wands, to digitize hard copy text, laptop with keyboard overlay, touch screen, Google Docs, Google classroom.
- Timers are used to assist students with on-task directions
- Speech recognition and prediction software provides students that are physically disabled to interact for the purpose of composition.
- Audible books, speech to type
