With our approved "Smart Schools Investment Plan - Wappingers\_WCSD\_Supplemental\_ #4" the District was able to purchase 183 Interactive Display Boards. We would now like to use SSBA funds for installation services as the task of installing all of these devices is no longer feasible with our limited internal staff.

There was a cost reduction from the time we submitted the proposal to when it was approved by SSBA. And in that time we found a cheaper source for the hardware. We wanted to stay within the original spending budget of \$450,000 for this items, hence the cost adjustments in section 12 below.
