**District in Good Standing:** A district is considered to be in good standing if it has not been identified as a District in Need of Improvement, Requiring Corrective Action, Planning for Restructuring, or Requiring Academic Progress.

**District Requiring Academic Progress:** Under the State component of New York's accountability system, a district that misses making AYP at every applicable grade level in a subject area for two consecutive years is considered a District Requiring Academic Progress (Year 1) for the following year. In each succeeding year that the school fails to make AYP, the year designation is incremented by one.

**District in Need of Improvement (Year 1):** A district that misses making AYP at every applicable grade level in the same subject area for two consecutive years while receiving Title I funds is considered a District in Need of Improvement (Year 1) for the following year.

**District in Need of Improvement (Year 2):** A District in Need of Improvement (Year 1) that misses making AYP at every

applicable grade level in the subject area for which it was identified while receiving Title I funds is considered a District in Need of Improvement (Year 2) for the following year.

**District Requiring Corrective Action:** A District in Need of Improvement (Year 2) that misses making AYP at every applicable grade level in the subject area for which it was identified while receiving Title I funds is considered a District Requiring Corrective Action for the following year.

**District Planning for Restructuring:** A District Requiring Corrective Action that misses making AYP at every applicable grade level in the subject area for which it was identified while receiving Title I funds is considered a District Planning for Restructuring for the following year.

**District Restructuring:** A District Planning for Restructuring that misses making AYP at every applicable grade level in the subject area for which it was identified while receiving Title I funds is considered a District Restructuring for the following year.

**To make Adequate Yearly Progress (AYP) in 2004–05, every accountability group must make AYP.**

2. *either* meet its Effective AMO *or* make safe harbor (*2004–05 Performance and Standards*).

To meet the participation requirement, 95 percent of the grade 4 enrollment in each accountability group with 40 or more students must be tested. To meet the

Effective AMO, the Performance Index for each group with 30 or more continuously enrolled students must equal or exceed the Effective AMO. To make safe harbor, the Performance Index of each of these groups must equal or exceed its ELA safe harbor target *and* the group must meet the elementary-level science qualification for safe harbor. Effective AMO, the Performance Index for each group with 30 or more continuously enrolled students must equal or exceed the Effective AMO. To make safe harbor, the Performance Index of each of these groups must equal or exceed its math safe harbor target *and* the group must meet the elementary-level science qualification for safe harbor. in Elementary-Level ELA and Math, the PI must equal or exceed the State Science Standard or the Science Progress Target in elementary-level science for that group. Groups with fewer than 30 students tested in elementary-level science are not subject to this qualification criterion.

**Science Progress Targets:** The elementary-level 2004–05 Science Progress Target is calculated by adding one point to the 2003–04 PI. The 2005–06 Science Progress Target is calculated by adding one point to the 2004–05 PI. The 2005–06 target is provided for groups whose PI was below the State Science Standard in 2004–05.

To make safe harbor, the Performance Index of each of these groups must equal or exceed its math safe harbor target *and* the group must meet the middle-level science qualification for safe harbor. Each group must also meet its Effective AMO or make safe harbor (**2004–05 Performance** and **Standards**). To meet the Effective AMO, the Performance Index for each group with 30 or more cohort members must equal or exceed the Effective AMO. To make safe

harbor, the Performance Index of each of these groups must equal or exceed its math safe harbor target *and* the group must meet the graduation-rate qualification for safe harbor. (See the graduation-rate page of this report for further information on meeting the graduation-rate qualification for safe harbor.)

**Math Safe Harbor Targets:** The secondary-level 2004–05 Math Safe Harbor Target is calculated by using the following equation:  $2003-04 \text{ PI} + (200 - \text{the } 2003-04 \text{ PI}) \times 0.10$ . **Qualification for Safe Harbor in Secondary-Level ELA and Math:** For an accountability group to be considered Qualified for Safe Harbor in Secondary-Level ELA and Math, the Percent Earning a Local Diploma by August 31, 2004 must equal or exceed the Graduation-Rate Standard or the Graduation-Rate Progress Target for that group.

**Graduation-Rate Progress Targets:** The 2004–05 Graduation-Rate Progress Target is calculated by adding one point to the Percent of the 1999 Cohort Earning a Local Diploma by August 31, 2003. The 2005–06 Graduation-Rate Progress Target is calculated by adding one point to the Percent of the 2000 Cohort Earning a Local Diploma by August 31, 2004. This target is provided for each group whose Percent Earning a Local Diploma by August 31, 2004 is below the Graduation-Rate Standard in 2004–05 (55). **Accountability Cohort:** The 2001 school accountability cohort consists of all students who first entered grade 9 in the fall of 2001, and all ungraded students with disabilities who reached their seventeenth birthday in the 2001–02 school year, who were enrolled on October 8, 2003. Students who transferred to programs leading to a high school diploma or high school equivalency diploma were not included in the 2001 school accountability cohort. The 2001 district accountability cohort consists of all students in each school accountability cohort plus students who transferred within the district after BEDS day *plus* students who were placed outside the district by the Committee on Special Education or district administrators and who met the other requirements for cohort membership. Cohort is defined in Section 100.2 (p) (8) of the Commissioner's Regulations.

**Adequate Yearly Progress (AYP):** Adequate Yearly Progress (AYP) indicates satisfactory progress by a district or a school toward the goal of proficiency for all students.

**Annual Measurable Objective (AMO):** The Annual Measurable Objective (AMO) is the PI value that signifies that an accountability group is making satisfactory progress toward the goal that 100 percent of students will be proficient in the State's learning standards for English language arts and mathematics by 2013–14. The AMO will be increased in regular increments beginning in 2004–05 until it reaches 200 in 2013–14. (See Effective AMO for further information.)

**Continuously Enrolled Students:** Students enrolled in the school or district on BEDS day (usually the first Wednesday in October) of the school year and until the day of testing.

**Effective Annual Measurable Objective (Effective AMO):** The Effective Annual Measurable Objective (Effective AMO) is the PI value that each accountability group within a school or district is expected to achieve to make AYP. The Effective AMO is the lowest PI that an accountability group of a given size can achieve in a subject for the group's PI not to be considered significantly different from the AMO for that subject. If an accountability group's PI equals or exceeds the Effective AMO, it is considered to have made AYP. A more complete definition of Effective AMO and a table showing the PI values that each group size must equal or exceed to make AYP are available at [www.emsc.nysed.gov/irts](http://www.emsc.nysed.gov/irts).

**Graduation-Rate Cohort:** Graduation-rate cohort for each year includes all students in the accountability cohort in the previous year plus all students excluded from that accountability cohort solely because they transferred to a general education development (GED) program.

**Graduation-Rate Standard:** The criterion value that represents a minimally satisfactory percentage of cohort members earning a local diploma. The State Graduation-Rate Standard is 55 percent. The Commissioner may raise the Graduation-Rate Standard at his discretion in future years.

**Performance Index (PI):** A Performance Index is a value from 0 to 200 that is assigned to an accountability group, indicating how that group performed on a required State test (or approved alternative) in English language arts, mathematics, or science. Student scores on the tests are converted to four achievement levels, from Level 1 (indicating no proficiency) to Level 4 (indicating advanced proficiency). ***At the elementary and middle levels, the PI is calculated using the following equation:  $100 \times [(Count\ of\ Continuously\ Enrolled\ Tested\ Students\ Performing\ at\ Levels\ 2,\ 3,\ and\ 4\ +\ the\ Count\ at\ Levels\ 3\ and\ 4) \div Count\ of\ All\ Continuously\ Enrolled\ Tested\ Students]$ .*** ***At the secondary level, the PI is calculated using the following equation:  $100 \times [(Count\ of\ Cohort\ Members\ Performing\ at\ Levels\ 2,\ 3,\ and\ 4\ +\ the\ Count\ at\ Levels\ 3\ and\ 4) \div Count\ of\ All\ Cohort\ Members]$ .*** A list of tests used to measure student performance for accountability is available at [www.emsc.nysed.gov/irts](http://www.emsc.nysed.gov/irts).

**Progress Target:** For accountability groups below the State Standard in science or graduation rate, the Progress Target is an alternative method for making AYP or qualifying for safe harbor in English language arts and mathematics based on improvement over the previous year's performance.

**Safe Harbor:** Safe Harbor provides an alternative means to demonstrate AYP for accountability groups that do not achieve their Effective AMOs in English or mathematics.

**Science Standard:** The criterion value that represents a minimally satisfactory performance in science. In 2004–05, the State Science Standard at the elementary and middle levels was a PI of 100. The Commissioner may raise the State Science Standard at his discretion in future years.
