

**Proportionate Share of IDEA Federal Funds for Parentally Placed Students with Disabilities in
Nonpublic Schools Located in the School District
For 2022-23 School Year**

IDEA requires school districts to provide special education services to students with disabilities who are parentally placed in nonpublic schools which are located in the school district. The information below is provided to assist school districts with the calculation of the proportionate share of IDEA funds under Sections 611 and 619 that should be used to provide special education services to parentally placed students in nonpublic schools which are located in the school district. The numbers of students used in this report are from the data provided by school districts through SIRS in the October 6, 2021 Special Education Snapshot template, specifically by submitting students with Primary Setting codes of SA08 and SA09.
